## POST BUDGET SESSION 2020

World Association for Small and medium Enterprises (WASME) organised Post Budget 2020 Round-Table Discussion Session on 01st February, 2020 at WASME International Secretariat, Plot No.4, Sector-16A, Film City, Noida, U.P-201301, India.

The aim of the session was to discuss about "The Union Budget 2020" presented by Hon'ble Finance Minister Mrs Nirmala Sitharaman.

Experts from various fields participated and discussed various aspects of budget in round-table discussion session named as:

Following points were highlighted & discussed by expert in the session as follow:

"The MSME sector will benefit from the proposal to extend the restructuring window, a scheme for provision of subordinate debt and digital solution to deal with delayed payments. Further easing of taxation burden on startups should support their ecosystem.

The proposal to set up large solar power capacity alongside rail tracks and enabling farmers to set up solar power generation capacity on their barren lands have the potential to herald immense growth opportunity for the renewable ener..

- While rationalisation of personal income taxes would revive demand, the focus on agriculture and social sectors would benefit broader economy. However, balancing the needs of economic revival amid very limited fiscal space is going to be a tightrope walk for the policymakers at least in the coming financial year.
- "Country has moved on from over 4% growth in 1950s to 7.4% to 2014-19 period.
- Total of 60 lakh new taxpayers and 105 crore e-way bills generated under GST. Average household now saves 4% of monthly spend due to reduced GST rates. Central government debt reduced to 48.7% of GDP in 2019 from 52.2%.
- Railways will setup Kisan Rail through PPP model so that perishable goods can be transported quickly, Krishi Udaan Scheme to transport Agri products to national as well international destinations to be launched.
- To boost infrastructure, 9,000 Km of economic corridor will be setup. "Chennai-Bengaluru expressway will also be started. Delhi-Mumbai expressway to be completed by 2023.
- 100 more airports to be developed by 2025. The FM also 1,150 trains will be run under the public private partnership (PPP) mode, also four stations will be redeveloped with the help of private sector. Besides, the minister promised more Tejas type trains to connect tourist destinations. An allocation of Rs. 8,000 crores will be made for National Mission on Quantum Computing and technology. An allocation of Rs 6,000 crore will be provided for BharatNet Scheme. Allocation of Rs 27,300 crore for development of industry and commerce. Agri-credit target for the year 2020-21 has been set at Rs. 15 lakh crore. Rs 69,000 crores for allocation for the healthcare sector. Rs. 99,300 crore allocated for education in FY21. Govt. will start Ind-Sat exam to promote study in India. A total Rs. 3,000 crores will be given for skill development. Zero-Budget farming is Govt's focus area. Allocation to rural development and Panchayati Raj setup at Rs. 1.23 lakh crore. Nominal growth of GDP for 2020-21 has been estimated at 10%.

- Focus on MSMEs: More than 5 lakh MSMEs benefited from RBI's restructuring of loans. "Government has asked RBI to consider extending window of debt structuring by one year to March 2021 for this purpose.
- Fiscal deficit target pegged at 3.8% of GDP for FY 2019-20. FY21 fiscal deficit target pegged at 3.5% of GDP.
- Women Schemes, senior citizens in Budget: enrolment ration for girls under "Beti Bachao Beti Padhao" is higher than boys. Further, Rs. 28,600 crores will be allocated in FY21 for women-linked programmes. Allocation for senior citizens and Divyang enhanced to Rs 9500 crores.
